Anticipated for November 1, 2026	Examination Specifications	Updated NBDHE Test Specifications are scheduled for implementation on November 1, 2026. These changes are not expected to substantially alter examination preparation but provide additional clarity and refinements to several content areas. Candidates should refer to the NBDHE Candidate Guide associated with their testing date for complete information regarding the applicable test specifications.

Admission Test for Dental Hygiene (ATDH)

Date	Topic	Notes
Implemented in 2023	Year-round Testing	Effective September 1, 2023, the ADA's Department of Testing Services (DTS) implemented year-round testing for the ATDH Program. This change provides candidates and dental hygiene programs with additional flexibility. Under year-round testing, a candidate is permitted to attempt the ATDH on any day of the year for which they can secure a testing appointment, provided they meet established ATDH eligibility criteria. The transition to year-round testing is also accompanied by an improvement in the speed with which ATDH results are reported to candidates and dental hygiene programs. Under year-round testing, results are reported within three to four weeks of the candidate's test date. In comparison, under the previous window-based system, results reporting sometimes required as much as 12 weeks. Additional information is available at the ATDH website, at ADA.org/ATDH.

Implemented in January 2022	Biology	Changes to the DAT Biology Test Specifications were implemented on January 21, 2022. Students who plan to take the DAT are encouraged to review the updated specifications, which include several new topics that were not previously covered on the examination.
Implemented in March 2025	Scoring and Reporting	Starting with administrations occurring on March 1, 2025, the 2-digit score reporting scale (1 to 30) was replaced by a 3-digit score reporting scale (200 to 600), and unofficial score reports are no longer be available at the testing site. Implemented in April 2026	Organic Chemistry	Updates to the DAT Organic Chemistry Test Specifications were implemented in April 2026. Additional information is available on the DAT webpage .
